YOU SAID	WE DID
Need to clarify in document that cases will cross several domains/categories	This has been clarified in the introduction
You need more information on the Mental Capacity Act (MCA)	The MCA is referred to in the document under supporting information and the overarching Multi-Agency policy will have more details on the MCA and safeguarding
You need to emphasise that the Framework it is not an exhaustive list of scenarios	This is clarified in the introduction
You need to publicise the Framework to GPs	A Draft Framework was taken to the Local Medical Council for review. GPs will also be included in the implementation plan
You need to be more explicit about self-harm	Self-harm is now included in the Framework
Debt bondage needs to be in the glossary	Debt bondage is now added to the glossary
The Framework needs to make it clearer that professionals can also use the complaints processes	In the support services section it now references that the complaints process can be used by professionals
You need to clarify the aim of the document	The aim of the document is now included on the front-page and also in the introduction
Pressure ulcers and falls need to be included in the title of the Domain	Pressure ulcers and falls are now included in the title of the domain
The response needs to be on the top with the actions taken at the bottom	The two boxes have now been swapped around
Pages need to be numbered in the document	All pages are now numbered
Remove lacks capacity in the main triangle	Lacks capacity has been removed from the main triangle
You need to include support services for housing	We are still waiting for a response, but will add housing as soon as we receive the information
You need to include historical sexual abuse	Historical sexual abuse is now included in the heading of sexual abuse

YOU SAID	WE DID
You need to reference harassment in the Framework	Harassment is now referenced within domains
You need to add Mate Crime	Mate crime is now added to a number of domains including physical, psychological
You need to include a focus on professional judgement	The introduction includes reference to professional judgement
Headings for blue and green solely relate to service provider issues	We have updated the wording in both blue and green boxes to ensure they are more generic and also removed service provider as well
You need to articulate what care management is	Care management is now included in the glossary and we have also changed the wording to the individual columns, it now reads local management
You need to change service user to person throughout document	The document now references person
For support services you need to refer to the page that they reference	This is now referenced
You need to add Ofsted to support services for sixth form colleges	Ofsted is now reference in support agencies
You need to include abuse between care receivers in the Framework	This is now referenced under a couple of the domains
Descriptors are very organisational focussed	We have changed the wording to ensure that the Framework is applicable in all settings
Support services need updating	A full update on all support services have been undertaken
You need to include support services for sources of risk	There is a section for support services for the source of risk
Pressure damage – there is no grading in the amber section	The group discussed this and felt that for amber and red, grading was not required as the cases should be referred into safeguarding or advice sought no matter what the grade was
You need to ensure that practitioners consider the wider context of the situation as well as using the tool	The introduction advises practitioners to use their knowledge and skills and consider wider context
Instructions need to flow about how you use the document	A flow chart of the process is being developed and will be added to the Framework
The title of the Framework needs to be changed to guide practitioners to its use	The working party discussed changing the title but felt that the definition of Framework best suited the document and how it is to be used
Up-skirting needs to be added to the Framework	Up-skirting has now been added to the Framework

YOU SAID	WE DID
Domestic abuse and modern-day slavery need to be referenced in the beginning as part of 3 stage process for identifying whether someone is at risk	Domestic abuse and modern-day slavery have now been highlighted further in the introduction
Psychological abuse section is focussed on institutions	The wording in this section has been updated to ensure that it does not solely focus on institutions
Online bullying needs to be included in the Framework	Online bullying has now been added to the Framework
The introduction needs to include how to use the document	The introduction has been updated to include the role the document plays in the safeguarding process. A flow chart is also going to be added
You need to clearly articulate how this Framework interacts with providers current policies and procedures	In the introduction it states that this Framework should be used in conjunction with providers local policies
Sex without consent vs rape needs to be reviewed – not in agreement with the Framework	The Framework has been updated and rape and sex without capacity has been included
